Registration: Thru August 21, 2017

Registration fee: \$5 Per Entry – Fee will be collected at the Competition

## RULES

1. **At least three ingredients in the salsa must be ingredients that could be purchased at the Medina Farmers Market.**
2. All contestants must arrive at the Farmers Market on August 26 by 10:00 am to complete their registration.
3. There are no age or resident restrictions to enter this contest.
4. Each participant may enter one (1) entry in each category.

### CATEGORIES:

- A) Sweet/Fruity Salsa – Judging at 11:00 am
- B) Mild Salsa – Judging at 11:30 am
- C) Hot Salsa – Judging at 12:00 noon

5. Each entry should be prepared fresh in advance. Due to space limitations, preparation on site will not be available.
6. Each entry should consist of one (1) pint for judging. Entry should be presented for judging in a pint jar. There can be no markings on the jar. A label will be provided at the competition
7. Chips will be provided for judging.
8. **NO FOODS THAT REQUIRE REFRIGERATION ALLOWED.** This rule is for health and safety reasons.
9. Be sure to mark your containers with your name on the bottom of the container, if you want it returned. It is your responsibility to pick up the container after the judging.
10. All entries **MUST** include the recipe on a 3x5 index card. Recipes may be published via website, newspaper, or cookbook.
11. Judging will be done by panel using the following criteria
  - a. Appearance
  - b. Consistency
  - c. Flavor
12. Awards – One winner will be selected in each of the three categories (Hot, Mild, or Sweet/Fruity) and a cash prize awarded.
